

Hello Friends,

This note is coming to you from TRU (Transparent Residents United)- a group of neighbors looking for positive change in our community. We did a rock mail last month and we're back this month-with some information about the recall and regular elections (yes, it's confusing!).

Let's start with the September election.

- This is a Recall Election and will be decided on September 30th.
- The Recall will happen whether you participate or not- it is required by law.
- (Yes- it's very close to the next election. But understand that the petition to recall the Board was received on May 4th... so this actually could have happened much sooner.)
- You will have the opportunity to replace zero, one, two, three, four or all five members of the current Board. If you like the current Board- you can vote for them all again.
- The ballot will ask you if you want to recall the Board: yes or no.
- Below your yes/no choice, you will find a list of 13 names. You will choose up to 5 of those names.
- If a quorum is met (153 or more votes are cast), and a majority of the quorum says yes, then 5 winning names will be selected from those listed on the ballot. The top 5 vote-getters will be the new Board.
- If a quorum is not met, those present may vote to reconvene soon after (no less than 5, no more than 30 days later) to complete the election with a reduced quorum of at least 25% (or 75 ballots).
- **We encourage you to complete the ballot, answering yes or no.**
- **And please make your choices for Board members...** this is a real election, and even with another election in November, new folks elected will have a chance to "try out" the job and demonstrate their capabilities.

In November, a regular annual election will be held.

- This election will likely take place on Tuesday, November 28th.
- If the Recall election replaces some or all of the current Board, we will still have a November election.
- This will be the typical annual election, where you receive the ballot and select 5 candidates.
- The 5 highest vote-getters will comprise the new Board.
- Important: you will also be asked to vote on Revised Bylaws and Revised CC&Rs. You should be receiving copies of the revised documents before it's time to vote.

In the case of both elections (or any Board election):

- You will receive your ballots by mail and can mail them -or- bring them to the Clubhouse, where there will be a locked ballot box.
- We suggest that you either photocopy or note your choices and when you mailed or dropped off your ballot.

- The Board will select officers (President, Vice President, Secretary and Treasurer) at their first meeting, which generally takes place directly after the voting is completed and winners have been announced.

We're looking toward a better future together.
